Regulation No. 61 of the Rector of the University of Lodz of 8 May 2019

on: establishing the fees for issuing and certifying documents

Pursuant to: art. 79, section 2 and art. 78, section 5 of the Act of 20 July 2018 – Law on Higher Education and Science (Polish Journal of Laws, 2018, item 1668 as amended), in conjunction with art. 264, section 2 of the Act of 3 July 2018 – Implementing Provisions – Law on Higher Education and Science (Polish Journal of Laws, 2018, item 1668), and art. 36, section 1 of the Regulation of Minister of Science and Higher Education of 27 September 2018 on studies (Polish Journal of Laws, 2018, item 1861, as amended), it is ordered as follows:

§ 1

1. The following fees are established:
 - 1) PLN 22 – for issuing an electronic student ID;
 - 2) PLN 60 – for issuing to a graduate, who participates in a study cycle beginning in the academic year 2018/2019 or earlier, a diploma with a diploma supplement and its two copies, including on the student’s request submitted by the end of the study period:
 - a) a copy of the diploma in English, French, Spanish, German or Russian,
 - b) a copy of the diploma supplement in English;
 - 3) PLN 20 – for issuing:
 - a) additional copy of the diploma in a foreign language,
 - b) additional copy of the diploma supplement in a foreign language,
 - c) diploma duplicate,
 - d) diploma supplement duplicate,
 - e) *overruled*,
 - f) *overruled*;
 - 4) PLN 26 – for the certification of documents to the extent performed by the university.
2. For issuing a duplicate of an electronic student ID, the fee is higher (half of the fee) than the fee for issuing an original student ID.
3. For students, who signed an agreement on payment conditions for educational services at the UL in the academic year 2018/2019 or earlier, fee referred to in section 2 is calculated

on the amount of PLN 17.

4. Graduates of a training cycle beginning in the academic year 2019/2020 or later shall not pay the fee referred to in section 1(2).

§ 1a

In the case of postgraduate studies, which started in the academic year 2018/2019 or earlier, the amount of fee for issuing a Postgraduate Diploma is established in accordance with the agreement on payment conditions for postgraduate studies.

§ 2

Dean may exempt the student, who has a difficult financial situation, from fees referred to in art. 1(1-2).

§ 3

Fees, referred to in art. 1(1-2), are paid by a student to the bank account indicated by the University of Lodz or in a place designated by the Rector.

§ 3a

Fee, referred to in art. 1, section 1, point 2, includes issuing a diploma with two copies and a diploma supplement until 30 September 2019.

§ 4

Regulation No. 41 of the Rector of the University of Lodz of 16 December 2015 on establishing the fees for issuing an electronic student ID, student report, diploma, postgraduate diploma and their duplicates, as well as for document certification is repealed.

§ 5

This Regulation enters into force on the day of its signing.
